Academic & Teaching Experience:

- Appointed Associate Professor at the sociology department of the **University of Crete** in 2023 previous appointments at the same department as Assistant Professor in 2016 and as Lecturer in 2014.
- Since 2011-2012 and up to the present I have been teaching various social theory courses on both undergraduate and postgraduate levels at the sociology department of the **University of Crete** in Greece
- In the spring terms of 2022-2023 and 2023-2024 I have taught 12 hours (each year) as invited Professor in the Master's Course *Sociology of Modernity*, at **ISCTE University**, Lisbon.
- In the winter term of the academic year 2010-2011 I delivered an intensive undergraduate module at the Philosophy Department of the **Alpen-Adria Universität Klagenfurt**, in Austria. This included intensive seminars that took place in Klagenfurt between the 25th and the 30th October 2010, distance teaching and supervision/marketing of essays.
- Between the spring term of 2008 and the spring term of 2010, I have been teaching one 2nd year- undergraduate seminar on Heidegger's "Letter on Humanism" and a 3rd/4th year- undergraduate module entitled "Levinas: Ontology and Ethics" at the Philosophy Department of the **University of Patras**, Greece.
- Since September 2004 and up to the present I am also teaching a module on 'Social Theory and Modernity' for the **Hellenic Open University**. My duties there are similar to those of Associate Lecturers at the Open University in the UK, while between 2017-2020 I was also appointed convenor of this module and between 2020 and 2022 I was Assistant Convenor of the same module.
- Between October 2004 and December 2007 I have been teaching social theory for the Department of Sociology of the **University of Crete** in Greece. More specifically, I have taught several seminars on key-aspects of contemporary social thought, one module on theories of Modernity, and the third year core module "Social theory III" (jointly with

Professor. K. Gounis). My duties included lecturing, tutoring and marking essays and exam papers.

- In the spring term of the academic year 2006-2007, I have been teaching one 2nd year-undergraduate seminar on Heidegger's "Letter on Humanism" and a 4th year-undergraduate core module on Heidegger at the Philosophy Department of the **University of Patras**, Greece.
- In the spring term of the Academic Year 2004-2005 I offered an introductory course to sociology for the Department of International Economic and Political Studies, at the **Macedonia University** of Thessaloniki, Greece. My duties there included lecturing, tutoring and marking exam papers.
- Between September 2003 and June 2004 I have been employed as a *Jean Monnet Research Fellow* (2003-2004) by the Department of Social and Political Sciences, at the **European University Institute**, Florence, Italy. In addition to being occupied with my research on 'Europe and History', I have been offering a seminar on modern philosophical conceptions of time and history of European origin and their importance for social and political thought. The seminar attracted doctoral researchers from the departments of Social & Political Sciences and History and focused mainly on the works of Kant, Herder, Hegel, Nietzsche, Schelling, Kierkegaard, Heidegger, Levinas, Patocka, Ricoeur and Derrida.
- During that time I have also co-organised -with Professor Peter Wagner and Dr. Vasiliki Tsakiri- an intra-European workshop on *Time and History* in modern and contemporary philosophy. The workshop complemented the subjects studied in the context of the homonymous seminar, while it took place at the **European University Institute** on the 3rd – 4th May 2004 with the participation of established philosophers and young researchers from European countries.
- During the academic year 2002-2003 I have been teaching one tutorial group for the second year undergraduate course "Theoretical Ideas", an introduction to Social Theory (Convenor: Dr. Charles Turner) for the Sociology Department, **University of Warwick**.
- Between November 2002 and January 2003 I have been teaching as a 'visiting lecturer' the course "Gender in contemporary Britain" for the sociology department, at the **University of Central England** (convenor: Dr. Joyce Canaan). My responsibilities included lecturing, teaching in tutorial groups and marking.
- During the spring term of the same academic year -again as a 'visiting lecturer'- I also gave four lectures and two seminars for the course 'Inequality and Society' (convenor: Dr. George Smith) at the sociology department of the **University of Central England**. The course is taught jointly by a team of lecturers.
- Between October 2000 and October 2003, I have been employed as an Associate Lecturer with the **Open University** in the West Midlands Region. I have been teaching two modules on a regular basis, the third-year undergraduate module D318 "Culture, Media and Identities" and the MA core-course D820, "The Challenge of the Social Sciences". The aim of the latter course is to familiarise students with epistemological issues and theoretical debates in the various fields of the social sciences and the humanities. Additionally, students are introduced to the various techniques employed in empirical research and to the –not always unproblematic- relationship between theories and their employment in empirical studies.
- In addition, I have taught the first-year undergraduate **Open University** module DXR220 "social Science in Action", which focuses on the "information Society". Significantly, this module involved teaching in the summer school in York for two consecutive weeks, from 11/08 to 25/08/2001. It also involved introducing students to qualitative research methods

and guiding them through their first hands-on experience of qualitative research and helping them generate their own data.

- I have also been employed as a consultant in an **Open University** committee reviewing the course materials (especially the student guides) for the 3rd year undergraduate module D318 “Culture, Media and Identities”. My responsibilities included participating in meetings and revising the “Tutorial Guide” for the course.
- During my time as an Associate Lecturer with the **Open University** I have also taught D813 and D820 to imprisoned OU students mainly in HMP Rye Hill and other confinement institutions in central England.
- In the first term of the academic year 1999-2000, I have been teaching four first-year undergraduate seminar groups for the module “Sociological Imagination and Investigation” (convenor: Peter Ratcliffe), offered by the Sociology Department, **University of Warwick**.
- In the second term of the academic year 1998-1999, while the present convenor of the MA in social and Political Thought professor Robert Fine was on sabbatical, I was appointed by the then convenor of the MA in Social and Political Thought, professor Peter Wagner to teach the late Professor Fine’s MA course “State and Civil Society”, jointly with Dr. Nick Ye Myint. This course was at the time part of the MA in Social and Political Thought offered by the Sociology Department, **University of Warwick**. The course examined the original political writings of Hegel, Marx, Luxembourg, Adorno, Marcuse, Arendt and Derrida and my duties included seminar teaching and essay marking.
