Maria Kousis (MA, PhD, The University of Michigan, 1984) is Professor Emerita of Development and Environment in the Department of Sociology, University of Crete and former Director of the University of Crete Research Centre for the Humanities, the Social and Education Sciences (UCRC). She has been coordinator of, and/or partner in European Commission funded research projects including Grassroots Environmental Action in Southern Europe, Transformations in Environmental Activism, Mediterranean Voices: Oral History and Cultural Practice in Mediterranean Cities and Participatory Governance and Institutional Innovation.

Her publications include 17 edited volumes/books/special issues and 44 articles, 43 book chapters, including *Economic and Political Contention in Comparative Perspective Boulder* (eds. M Kousis and C. Tilly, Paradigm Publishers 2005), a Special Issue of *American Behavioral Scientist* on *Alternative Action Organizations During Hard Economic Times: A Comparative European Perspective* (with S. Kalogeraki and C. Cristancho, 2018), *Transnational solidarity in times of crises: Citizen organisations and collective learning in Europe* (eds C. Lahusen, U. Zschache and M. Kousis, Palgrave 2021) focused on the fields of migration, disability and unemployment and *Challenging Mobilities in and to the EU during times of crises: the case of Greece* (with A. Chatzidaki and K. Kafetsios, Springer 2022).

Her research centers on social change, contentious politics, the impacts of crises, environmental politics, migration and Southern Europe. Her latest work focuses on the socio-economic and political dimensions of hard times, particular in the context of the research projects *The Greeks, the Germans and the Crisis* (GGCRISI, Greek-German Ministries Cooperation), *Living with Hard Times: How European Citizens Deal with Economic Crises and Their Social and Political Consequences* (LIVEWHAT, EC, FP7), *European Paths to Transnational Solidarity in times of crisis* (TransSOL, EC, Horizon 2020), EURYKA (EC, Horizon 2020) and *Social and Solidarity Economy, Urban Communities and the Protection of Vulnerable Groups* (Swiss Network for International Studies).
